## TMBC projects merge for superb results

Teamwork is the component vital to so much of the work that TMBC does. Most times, the team consists of TMBC, USDA agencies, and other state and local organizations. However, it is the every-day combination of TMBC projects that goes less noticed.

A prime example of TMBC projects and other organizations coordinating efforts and staff for a single purpose occurred on February 23 in Benavides, Texas. The event, titled "Prescribed Burning for Range and

Wildlife", brought together USDA NRCS employees from Starr and Duval Counties and Grazing Land Conservation Initiative (GLCI) staff. It also involved three of the five TMBC projects.



The workshop was initially put together by the Frontera Agriculture Ranch Management (FARM) Project, which is funded by RMA and specializes in providing informational and educational workshops for farmers and

ranchers. Other projects that were included in the day's events were the Electronic Farm and Ranch (eFARM) Project and Technical Service Provider (TSP) Project.

Aisha Cruz, eFARM Project Director, described the several projects administered by TMBC, including eFARM, a computer, Internet, and electronic government training program provided free of charge to farmers and ranchers in rural areas.

Following the informational meeting, participants were invited to witness a prescribed



burn. The burn was administered by Duval County NRCS and GLCI with the help of TMBC employee Beto Gonzalez. Gonzalez is one of four TSP Project staff members. The TSP Project provides for man-power in NRCS offices in the South Texas areas.

The culmination of several TMBC projects, resulted in a productive and interesting workshop for ranchers in Duval County and is typical for all TMBC activities.

Since September 1, 2006, the FARM Project has provided four meetings to 178 participants. Producers are notified by mail. To date, 32, 248 letters have been sent out.
